HOLIDAY FOOD AND GIFT BASKET LAUNCHES MAY FUND DRIVE

Watch your mailboxes later this month for the 2010 spring fund appeal from the Holiday Food and Gift Basket. Our need for donations is greater than ever this year. The increasing demand on the OPRF Food Pantry and the exciting new changes underway there has meant a necessary reduction in the Pantry's financial support of the food gift certificates which are an integral part of the Holiday Food and Gift Basket program.

Last year we successfully served 958 referrals representing more than 2300 family members, senior citizens and single adults. Every household received a food gift certificate prior to Thanksgiving.

The insights of those who refer people to the HFGB powerfully demonstrate how important these food gift certificates are to those in need.

"...many of the folks who receive the gift cards are either alone for the holidays or have no family...the gift card seems to make accepting this fact easier and a tradition has begun where some will get together and share the food they purchased with the card. They kinda' make a party for themselves."

"... my clients use the gift card to pick up something special to bring to a Christmas dinner with friends... or family they are not completely estranged from... They are genuinely happy and excited they were able to do something a little different and "splurge" a little when so often they are living check to check.

"The program and gift certificates are valuable on many levels, not just the financial assistance it provides clients who are on set budgets and otherwise couldn't afford holiday extras, but the comfort and warmth clients feel from being remembered during an often lonely holiday season."

How the <u>American Recovery and Reinvestment Act</u> of 2009 helped the Oak Park River Forest Food Pantry serve high quality food to 11,000 families in 2009

When you are hungry in Illinois, where do you turn? For over 11,000 families in the Oak Park and River Forest (OPRF) area, that place of sustenance is the OPRF Food Pantry. As part of the Illinois Emergency Food Assistance Program, OPRF Food Pantry steps in to feed local families in their time of crisis. Like most member agencies, we provide families with an emergency ration of food, striving to supply enough for three days worth of meals.

In 2009, we set a goal of boosting the nutritional make-up of the food we provide. Specifically, we committed to including two dairy products and two frozen meat products to all families as part of their 3-day supply of food. Yet providing even that minimal amount became more and more challenging as the year progressed. By June, 2009 we had served 4961 families. For the same time period in 2008 we had served 2913 families. Could we continue to supply meat and dairy to exponentially increasing numbers of families? Not without help.

Fortunately, the USDA with the help of Stimulus Funds provided a much needed boost. In July, our allotment of USDA commodities leaped from an average of 7499 pounds to 12,137 pounds due to ARRA funds. So while we ended 2009 with a 63% increase in client visits, we also ended 2009 with a 58% increase in USDA allotments. The USDA allotment increase enabled us to continue providing quality, nutritious food to everyone in need who came to us for help. Without those extra commodities, we would have been forced to eliminate dairy and meat products in favor of less costly cans of vegetables and soup. The extra nutrition content of our food has not been lost on our clients. One of our clients recently remarked that "it helps people in need like myself have the food I can't afford to buy. The foods are very healthy for the body." Another noted "I am receiving food stamps, but I find it very hard to eat three meals on less than four dollars a day." Yet another commented that "the Pantry means a meal or no meal at all–and when you have odds and ends, the pantry helps fill in to make a meal for my family."

We could not have afforded to continue providing significant amounts of nutritious food to all our clients in 2009 without the increase in our allotment of USDA commodities. One of our clients says it best: "Bless you and all the workers. I can sleep at night because my stomach is full."

INCLUSIONARY ZONING PRESERVING OAK PARK'S VIBRANCY

Oak Park has long been a nationally-recognized proponent of integration and diversity. To counter white flight from Austin in the 1960s, Oak Park adopted a fair housing ordinance that embraced imminent racial change. In 1973, the board of trustees passed its first statement that affirmed the value and importance of diversity in the community. Since then the community has been at the forefront of promoting the progressive environment and values that brought many of us here to live.

At a time of rising foreclosures and high unemployment, Oak Park needs to ensure that diversity remains intact. One avenue to keep diversity alive and vibrant is to provide new housing that will allow low to moderate income people to remain here, raise their families and keep Oak Park a robust community.

Housing advocates in this community and elsewhere feel that one important means of retaining that value is passage of an inclusionary zoning ordinance. The Oak Park Temple Social Action Committee hopes to engage the congregation around formation of a community-wide coalition to adopt such a measure here in Oak Park.

We invite you to attend and learn about efforts around inclusionary zoning during a forum at 10:30 a.m., Sunday May 16 in the Chapel of Oak Park Temple at 1235 N. Harlem Avenue, Oak Park. This is the third panel in a series on housing and homelessness, which the board of directors 18 months ago approved as the issue Social Action could concentrate on. A three-person panel will explore regional and national efforts and address the experience of Highland Park, the first community in Illinois to adopt an inclusionary zoning ordinance.
